## REGULATIONS

The ISU World Junior Speed Skating Championships 2018 will be held in accordance with the 2016 Regulations of the International Skating Union (ISU) and relevant ISU Communications, in particular ISU Communication No. 2118. Participation in the ISU World Junior Speed Skating Championships is open to Junior Skaters who belong to an ISU Member (Rule 130, paragraph 1). A Junior is a Skater who has not reached the age of 19 by July 1, 2017 (Rule 108 paragraph 1b) and has achieved the required qualifying times according to ISU Communication No. 2118.

The Championships will include the following events:

- Ladies, single distances: 500m, 1000m, 1500m, 3000m, Mass Start (10Laps)
- Men, single distances: 500m, 1000m, 1500m, 5000m, Mass Start (10Laps)
- Ladies Allround Combination: 500m, 1000m, 1500m, 3000m
- Men Allround Combination: 500m, 1000m, 1500m, 5000m
- Team Competition Ladies: Team Pursuit race over 6 laps by national teams of 3 Skaters; Team Sprint race over 3 laps for national teams of 3 Skaters
- Team Competition Men: Team Pursuit race over 8 laps by national teams of 3 Skaters; Team Sprint race over 3 laps for national teams of 3 Skaters


## TRACK

The Utah Olympic Oval is an indoor artificial ice rink with a standard speed skating track of 400 meters to the lap. The radii of the inner and outer competition lanes are 26 m and 30 m meters, respectively. The width of the warm-up lane is 4 meters.

## TITLE AND AWARDS

The winners of the allround combination are the Skaters with the lowest total points after 4 distances have been completed (Rule 265, paragraph 2 and Rule 268, paragraph 1). The winner will bear the title: "Lady World Junior Allround Speed Skating Champion for 2018" and "World Junior Allround Speed Skating Champion for 2018" respectively (Rule 133, paragraph e), and will each be awarded the ISU Championships gold medal. The Skaters placed second and third in the final classification after 4 distances will be awarded the ISU Championships silver and bronze medals respectively.
The winners of the distances will bear the titles "Lady World Junior Speed Skating Champion $\qquad$ meters for 2018" and "World Junior Speed Skating Champion meters for 2018", respectively (Rule 133, paragraph g), and will be awarded the ISU Championships gold medal. The Skaters placed second and third in the respective distance will be awarded the ISU Championships silver and bronze medals.
The winners of the Mass start events will bear the titles "Lady World Junior Speed Skating Champion Mass Start for 2018" and "World Junior Speed Skating Champion Mass Start for 2018", respectively (Rule 133, paragraph g), and will be awarded the ISU Championships gold medal. The Skaters placed second and third in the respective distance will be awarded the ISU Championships silver and bronze medals.
The winning teams of the Team events will bear the titles "Ladies World Junior Speed Skating Team $\qquad$ Champions for 2018" and "World Junior Speed Skating Team Champions for 2018" (Rule 133, paragraph f), and will be awarded the ISU Championships gold medals. The teams placed second and third will be awarded the ISU Championships silver and bronze medals.

Prize money will be awarded according to ISU Communication No. 1976, or any further update of this Communication.

## ENTRIES

a) Entries can only be made using the ISU Online Entry System for Speed Skating Events on www.isu.org, section Speed Skating or at http://isu.events/login.php
b) Each ISU Member may enter a maximum 5 Ladies and 5 Men, (Rule 208, paragraph 7). Only Skaters who have achieved the qualifying times listed in ISU

Communication No. 2118 during the seasons 2016/2017 or 2017/2018 may be entered:

c) To compete in the Allround event the Skaters must have been entered for all the four distances above.
d) To be entered for the Mass start event or for a Team event a Skater must have achieved at least one of the above mentioned qualifying times. However, for these events and exception may be made for a maximum one Skater per ISU Member if so requested by the ISU Member. Exceptions will only be granted for Skaters who have reached the following qualifying limits:

For Ladies: 1500 m time of $2: 17,00$

For Men: 1500m time of 2:03,00
Further details on the entry rules are given in ISU Communication No. 2118, paragraphs 2.1.d) and 4.2.b).
e) The Preliminary Entries with the estimated number of Competitors and the number of coaches and other team staff as well as provisional names of the Competitors and Team leader must be communicated to the Organizing Committee at the latest by February 19, 2018 (Rule 208, paragraph 8).
f) Final Entries including the names of the Competitors and the substitute as well as the names of the Team leader, coaches and other steam staff for whom an accreditation is required must reach the Organizing Committee at the latest by 12:00 noon (local time) on March 6, 2018 (Rule 208, paragraph 8).

Please note that for all persons entered by the ISU Members the procedures regarding the Declaration for Competitors and Officials (all team officials requiring an accreditation) entering the ISU event (Rule 131) as outlined in ISU Communication 1628 need to be strictly observed. For more details please refer to Rules 115, 131, 208 and ISU Communication No. 1628 and 1797.

CITIZENSHIP/RESIDENCE REQUIREMENTS AND CLAREANCE PROCEDURE In accordance with Rule 109 of the ISU Regulations and ISU Communication No. 2030 all Skaters who do not have the nationality of the ISU Member by which they have been entered or who, although having such nationality, have in the past represented another ISU Member, must produce an ISU Clearance Certificate.

## DRAWING

The drawings will be made in accordance with Rules 239 and 243.

## ANTI-DOPING CONTROL

Anti-Doping tests will be carried out in accordance with the valid ISU Anti-Doping Rules and ISU Anti-Doping Procedures (ISU Communications No. 1922 and 2117 or any further update of these Communications).

## LIABILITY

In accordance with the ISU General Regulations (Rule 119), the ISU, US Speedskating and the Organizing Committee assume no responsibility for or liability with respect to bodily or personal injury or property loss or damage incurred in connection with this ISU Championships. Each ISU Member is solely responsible for providing insurance coverage thereto.

## TRAINING TIMES

The speed skating track will be open for training for entered Competitors from Monday, March 5, 2018 during designated times. Trial starts will be organized on Thursday, March 8, 2018.
Only accredited Competitors, substitutes and team officials will be allowed to enter the ice-rink during the official training hours.

## ACCOMMODATION

The Organizing Committee will be responsible for expenses for board and lodging at the official hotel from lunch on Thursday, March 8, 2018 until lunch on Monday, March 12, 2018 (Rule 137, paragraphs 10 and 14) for up to 5 Competitors (Ladies and Men respectively) and 1 Team leader or coach for each ISU Member. Expenses of other Skaters and officials (i.e. coaches, other team staff members and accompanying persons) other than those mentioned above, and expenses before or after the period mentioned above will be at the teams own expense.

Accommodation requests can only be made using the ISU Online Entry System for Speed Skating events.
The Organizing Committee requests to be informed about the accommodation needs of the competitors and team officials as soon as possible, but no later than Friday, February 2, 2018. Unused Junior World Cup block rooms will be released back to the hotel as of Saturday, February 3, 2018.
Rates and availability cannot be guaranteed after this date. Teams who do not arrive on their schedule date will be charged for unused reserved rooms.
The Organizing Committee reserves the right to limit the number of hotel rooms available to each team at the official hotel. The organizer is not obliged to provide services for an excessive number of team officials or other accompanying persons from participating ISU Members.
