Regulations

The International Thialf Race 2023 will be held in accordance with the 2024 Regulations of the International Skating Union (ISU) and relevant ISU Communications.

Track

Thialf Ice stadium is an indoor artificially frozen ice rink with a standard track of 400 meters and inner and outer curves with radii of 26 and 30 meters respectively. The width of the inside training track is 4 meters.

Participating / Entries

Participating in the International Thialf Race 2023 is open to Juniors- Senior skaters.

The entries and participation are based on the rules of entry of the KNSB:

However some spots are on invitation, others are open to submit. The KNSB invites other ISU members to participate and guarantees the skaters a spot in the competition. This applies to skaters that are actively participating in the ISU Centre of Excellence in Heerenveen.

Entries should be in September 17th before 24:00.

Drawing

Drawings will be made by the VANTAGE system.

Time measurement

Time measurements will take place by Electronic timekeeping and Manual timekeeping to determine the time and the order of finish of Skaters.

Anti-Doping

Anti-Doping tests will be carried out in accordance with the valid ISU Anti-Doping Rules and ISU Anti-Doping Procedures (ISU Communication No. 2243 or any further update of these Communications).

Officials

The allocation of officials will be the responsibility of the KNSB.
