### **Program**

Saturday, September 16 Starting from 12:30 local time

Sunday, September 17 Starting from 12:30 local time.

Time schedule will be provided by the KNSB.

### **Regulations**

The Plaatsings wedstrijd HC1 2023 will be held in accordance with the 2022 Regulations of the International Skating Union (ISU) and relevant ISU Communications.

### **Track**

Thialf Ice stadium is an indoor artificially frozen ice rink with a standard track of 400 meters and inner and outer curves with radii of 26 and 30 meters respectively. The width of the inside training track is 4 meters.

### **Participating / Entries**

Participating in the Plaatsings wedstrijd 2023 is open to Junior- and Senior skaters.

The entries and participation are based on the rules of entry of the KNSB:

However some spots are on invitation, others are open to submit. The KNSB invites other ISU members to participate and guarantees the skaters a spot in the competition. This applies to skaters that are actively participating in the ISU Centre of Excellence in Heerenveen. Entries should be in September 10<sup>th</sup> before 24:00.

### **Drawing**

Drawings will be made by the VANTAGE system.

### **Time measurement**

Time measurements will take place by Electronic timekeeping and Manual timekeeping to determine the time and the order of finish of Skaters.

### **Anti-Doping**

Anti-Doping tests will be carried out in accordance with the valid ISU Anti-Doping Rules and ISU Anti-Doping Procedures (ISU Communication No. 2243 or any further update of these Communications).

### **Officials**

The allocation of officials will be the responsibility of the KNSB.
